# **Call to Order and Public Comment**

#### **SFY26 Community Investment Plan Update**

- Roots and Wings Foundation Murray requested the Prevention Board allow the Executive Committee to award the FRC grants funded with Roots and Wings Foundation money. Cook moved to approve the Executive Committee to authorize sending letter of intent to award at the October Executive Committee meeting and Snyder seconded the motion. Motion carried. - Tribal Primary Prevention Request for Application Olivier moved to release funds for Tribal Primary Prevention grants and Breese seconded the motion. Motion carried. Arango-Escalante recused.
- SFY26 Community Investment Plan Horozewski moved to approve the updated SFY26 Community Investment Plan and Ellithorpe seconded the motion. Motion carried. Arango-Escalante recused.





## **Public Policy Committee Report**

Billings reported on the SFY25-27 state budget. She also reported that the Children's Caucus hosted an event in June on child advocacy centers and will host an event in September on children's mental health. The Public Policy Committee will schedule a meeting to discuss some pending legislation.

# **Performance Improvement Committee Report**

Olivier reported the committee has not met since the last meeting. The committee is working on the Community Investment Report for the November meeting.

# **Celebrate Children Foundation Report**

Snyder moved to approve Lozano as the new Foundation board members and Billings seconded the motion. Motion carried. Lozano abstained. Murray reported the Foundation endowment has been moved to a different management organization and some has been moved the Madison Community Foundation. The Foundation is doing some fundraising to offset the decline in license plate revenue.

#### **Board Member Updates**

Incitti reported on DPI's Mandatory Reporting of Child Abuse and Neglect Training for all school employees.

## **Staff Report/Updates**

Murray presented staff updates, including that the \$4.8 million budget request to support FRCs was not part of the final budget. She reported on the results of the Prevention Board director survey and the grantee survey.
